**FACTS:** The conveyor chain was replaced when the sidebar would break at the

attachment and the wheels that roll on the rails would have a flat spot, so the wheels would slide only, causing a lot of downtime. They would constantly

change a section or connection links to keep the chain running.

Webster's cost was 10% more than competitions chain.

Labor cost at the plant is \$65.00 per hour.

Replacing the chain takes two (2) men four (4) hours.
